JASPER COUNTY HIGHWAY DEPT. COUNTY ENGINEER

**First:** The Applicant represents all parties in interest and shall furnish materials, do all work, pay all costs, and shall in a reasonable length of time restore the damaged portions of the highway to condition similar or equal to that existing before the commencement of the described work, including any seeding or sodding necessary.

**Second:** The proposed work shall be located and constructed to the satisfaction of the County Engineer or his duly authorized representative. No revisions or additions shall be made to the proposed work on the right-of-way without the written permission of the County Engineer. County requires all lines greater than 1" of size to be encased.

**Third**: The Applicant shall at all times conduct the work in such a manner as to minimize hazards to vehicular and pedestrian traffic. Traffic controls and work site protection shall be in accordance with the applicable requirements of Chapter 6 (Traffic Controls for Highway Construction and Maintenance Operations) of the Illinois Manual on Uniform Traffic Control Devices for Streets and Highways and with the traffic control plan if one is required elsewhere in the permit. All signs, barricades, flaggers, etc., required for traffic control shall be furnished by the Applicant. The work may be done on any day except Sunday, New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. Work shall be done only during daylight hours.

**Fourth:** The work performed by the Applicant is for the bona fide purposed expressed and not for the purpose of, nor will it result in, the parking or servicing of vehicles on the highway right-of-way. Signs located on or overhanging the right-of-way shall be prohibited.

**Fifth:** The Applicant, his successors or assigns, agrees to hold harmless and indemnify the County of Jasper in the State of Illinois and its duly appointed agents and employees against any action for personal injury or property damage sustained by reason of the exercise of this permit.

**Sixth:** The Applicant shall not trim, cut or in any way disturb any trees or shrubbery along the highway without approval from the County Engineer or his duly authorized representative.

**Seventh:** The County reserves the right to make such changes, additions, repairs, and relocations with its statutory limits to the facilities constructed under this permit or their appurtenances on the right-of-way as may at any time be considered necessary to permit the relocation, reconstruction, widening or maintaining of the highway and/or to provide proper protection to life and property on or adjacent to the right-of way. However, in the event this permit is granted to construct, locate, operate, and maintain utility facilities on the County right-of-way, the Applicant, upon request by the County Engineer, shall perform such alterations or change of location of the facilities, without expense to the County, and should the Applicant fail to make satisfactory arrangements to comply with this request within a reasonable time, the County reserves the right to make such alterations or change of location or remove the work, and the Applicant agrees to pay for the cost incurred.

**Eighth:** This permit is effective only insofar as the county has jurisdiction and does not presume to release the Applicant from compliance with the provisions of any existing statutes or local regulations relating to the construction of such work.

**Ninth:** The Applicant affirms that the property lines shown on the attached sheet(s) are true and correct and binds and obligates him to perform the operation in accordance with the description and attached sketch and to abide by the policy regulations.

## PROVISIONS FOR UNDERGROUND UTILITY LINES

The following provisions supplement the attached Jasper County Highway Permit and these provisions which govern the construction of attached permit and in case of conflict with any part of said permit, the said provisions shall take precedence and shall govern.

The Petitioner shall notify the County Highway Department at least one week before construction of this line begins. The County Highway Department will then go over, with a representative of the facility along the highway.

The Petitioner will shape, fertilize, seed and straw all right-of-way damage in construction of this line. The following quantities will be used:

Fertilizer: 10-6-4 800 lbs. Per acre

Seed: 50 lbs. Blue Grass, 16-lbs. perennial rye

8 lbs. red tope and 2 lbs. White Dutch Clover per acre

Straw: 2 tons per acre

That this permit is granted upon the express condition and provision that authority or permission to use the lands to be occupied by the described facilities shall be secured from land owners or public authorities as and where required by law.

That the proposed \_\_\_\_\_\_\_, including fixtures, and appurtenances, shall be located and constructed in accordance with the description, special provisions, and plans attached hereto and made a part hereof, and the Petitioner shall thereafter operate and maintain said facilities, all to the satisfaction of the County Engineer or his duly authorized representative, and all work and material shall conform to the Standard Specifications of the State of Illinois, Department of Transportation, Division of Highways, wherever such specifications shall apply.

That the Petitioner agrees not to interfere with, obstruct, or endanger traffic on said highway and shall take all necessary precautions to protect traffic by use of signs, signals flagmen and watchmen.

That all pipe, fixtures and appurtenances shall be located in such a manner that they will not obstruct drainage or interfere with traffic, highway entrances or the maintenance of the highway.

That the Petitioner shall assume all responsibility for interference with existing utilities in, along, o upon said highways.

Whenever any of the work under this permit involves any obstruction or hazard to the free flow of traffic in the normal traffic lanes, plans for the proposed method of traffic control must be submitted to and approved by the County Engineer at least 72 hours, and preferable longer, before the start of work.

All traffic control shall be in accordance with State of Illinois Manual of Uniform Traffic Control devices and amendments thereof. It should be noted that standards and typical placement of devices shown in the Uniform Manual are minimum. Many locations may require additional or supplemental devices.

The County of Jasper in State of Illinois, through its representative, reserves the right to stop work on this project at any time, it is determined that requirements of this permit are being violated.

The Jasper County Highway Department shall in no way be held accountable for any accidental breakable or damage to the facility due to any maintenance work or operations of the Jasper County Highway Department.
