

A CITY OF NEWTON ORDINANCE  
TO AMEND THE RULES OF ORDER  
OF DELIBERATIONS AND MEETINGS OF  
CITY COUNCIL OF THE CITY CODE OF  
THE CITY OF NEWTON, ILLINOIS

WHEREAS, Chapter 1-2-11 of the Newton Municipal Code sets forth the Rules of Order and Procedure governing deliberations and meetings of the City Council as allowed by 65 ILCS 5/3.1-40-15; and

WHEREAS, it is proposed that the Order and Procedure to govern deliberations and meetings of the City Council be amended.

NOW, THEREFORE, BE IT ORDAINED THAT: Chapter 1-2-11 of the Municipal Code of the City of Newton, Jasper County, Illinois be and hereby is amended to establish the Order of Business as follows:

2. PLEDGE OF ALLEGIANCE.
3. ROLL CALL.
4. ADOPT OR AMEND AGENDA.
5. APPROVAL OF REGULAR MEETING.
6. APPROVAL OF BILLS AND ACCOUNTS PAYABLE.
7. PUBLIC COMMENTS/COMMUNICATIONS.
8. COMMITTEE REPORTS AND/OR COUNCIL REPRESENTATIVE REPORTS.
9. OLD BUSINESS.
10. NEW BUSINESS.
11. STATEMENTS BY: COUNCIL MEMBERS, CITY ATTORNEY, CITY TREASURER, CITY CLERK AND MAYOR.
12. SCHEDULING OF NEXT REGULAR MEETING AND SCHEDULE COMMITTEE MEETINGS.
13. EXECUTIVE SESSION.
14. ADJOURNMENT.


This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


